1. INTRODUCTION

The Sideline Podcast (“we,” “us,” or “our”) respects your privacy and is committed to protecting your personal data. This Privacy Policy outlines how we collect, use, and safeguard information gathered through our website (thesidelinepodcast.com), Instagram DM automation (N8N), email newsletters, and more.

2. INFORMATION WE COLLECT

We collect several types of information from and about users of our services and platforms, including but not limited to:

Identity Data

Name, age (for youth athletes), and social media handles.

Contact Data

Email address, phone number, and physical location (specifically for local NoVA events).

Technical Data

IP addresses, browser types, and usage patterns gathered via website cookies and platform analytics (YouTube, Spotify, Instagram).

4. CHILDREN'S PRIVACY (COPPA COMPLIANCE)

Because we highlight youth sports, we take children's privacy seriously.

We do not knowingly collect personal information from children under 13 without verifiable parental consent.

Youth highlight submissions MUST be submitted by a parent, legal guardian, or authorized coach.

If we learn we have collected personal data from a child under 13 without parental consent, we will delete that information immediately and follow the appropriate channels if we intend to use the content of the material.

5. DATA SHARING & THIRD PARTIES

We do not sell your personal data. We share information only with service providers we use for our daily operations and our affiliates:

Service Providers

N8N (automation), Google (hosting/forms), Godaddy, and our email service provider.

Affiliates

Chantilly Youth Association (CYA), CYA Fieldhouse etc for local event coordination.

Legal Enforcement

If and when required by law or to protect the safety of our guests and attendees at The Fieldhouse or any of our locations.
